2022 ORDINANCE AMENDMENT

**ORDINANCE OF THE MAYOR AND COUNCIL OF THE TOWNSHIP OF
BLOOMFIELD, IN THE COUNTY OF ESSEX, STATE OF NEW JERSEY,
AMENDMENT TO CHAPTER 315 OF THE TOWNSHIP CODE, PERMITTING THE
OPERATION OF CERTAIN CLASSES OF CANNABIS BUSINESSES IN THE
BLOOMFIELD CENTER REDEVELOPMENT PLAN - PHASE I**

WHEREAS, on February 22, 2021, Governor Murphy signed into law P.L. 2021, c. 16, known as the “New Jersey Cannabis Regulatory, Enforcement Assistance, and Marketplace Modernization Act” (the “Act”), which legalizes the recreational use of marijuana by adults 21 years of age or older, and establishes a comprehensive regulatory and licensing scheme for commercial recreational (adult use) cannabis operations, use and possession; and

WHEREAS, on August 16, 2021, the Township Council of the Township of Bloomfield adopted an Ordinance allowing and regulating one or more classes of cannabis business within Bloomfield, finding it to be in the best interest of the health, safety and welfare of Township of Bloomfield’s residents and members of the public who visit, travel, or conduct business in Township of Bloomfield, and amending the Township of Bloomfield’s zoning regulations to permit those cannabis-related activities, including land use and development, within certain geographic boundaries within Bloomfield; and

WHEREAS, the Township Council determined that the selling of cannabis and cannabis items to consumers from a retail store by a cannabis retailer shall be a conditional use in all B2 and CBD zones, with Planning Board approval required, subject to meeting the conditions set forth in any applicable zoning ordinance or receiving a variance from one or more of those conditions in accordance with the “Municipal Land Use Law,” P.L.1975, c.291 (C.40:55D-1 et seq.); As dictated by the Township’s enabling Ordinance, a total of no more than six Cannabis Retailers are permitted throughout the Township, with two permitted in the Northern Sector of the Township (including the portion of the B-2 Zone north of the Bay Avenue centerline); two permitted in the Central Sector (including the portion of the B-2 Zone south of the Bay Avenue centerline); and two permitted in the Southern Sector, irrespective of which of the two zones they may be located in. At least three of the six Cannabis Retailers permitted in the Township shall

be a microbusiness. No variance shall be granted permitting any greater number of Cannabis Retailers or microbusinesses either throughout the Township or in any individual Sector; and

WHEREAS, the Mayor and Council recognize that further permitting cannabis retail within the Commercial Corridor of the Bloomfield Center Redevelopment District - Phase I (the “BCRD Phase I Commercial Corridor”) would provide added stimulus to the economic vitality of the area as well as increased opportunity for new businesses, microbusinesses and property owners in the area; and

WHEREAS, retail stores are currently a permitted use within the BCRD-Phase I Commercial Corridor; and

WHEREAS, concurrent with this Ordinance’s introduction on First Reading, the Mayor and Council are introducing on First Reading an Ordinance to amend the Bloomfield Center Redevelopment Plan-Phase I (“BCRP-I) to permit cannabis retail sales as a permitted use within the BCRD-I Commercial Corridor, subject to certain regulations; and

WHEREAS, the Municipal Land Use Law (“MLUL”) requires in N.J.S.A. 40:55D-26 that all ordinances constituting a development regulation must be referred to the Planning Board for review to determine whether there are any inconsistencies between the proposed ordinance and the Township Master Plan and for any other recommendations the Planning Board may have with respect to the proposed ordinance; and

WHEREAS, concurrently with this Ordinance’s introduction on First Reading, the Mayor and Council shall adopt a Resolution referring this Ordinance to the Planning Board for review pursuant to N.J.S.A. 40:55D-26; and


NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Township of Bloomfield, Essex County, New Jersey, as follows:

Section 1. The aforementioned recitals are incorporated herein as though fully set forth at length.

Section 2. Chapter 315, Section 39(B), 9(a) shall be amended to permit the operation of certain classes of cannabis businesses within the BCRD-Phase I Commercial Corridor.
