2022 ORDINANCE NEW ORDINANCE

AN ORDINANCE ESTABLISHING CHAPTER 5, "ADMINISTRATION OF GOVERNMENT," Part 6. Additional Committees, Boards and Commissions, ARTICLE XXVI "Bloomfield Cultural Preservation Advisory Committee," IN THE CODE OF THE TOWNSHIP OF BLOOMFIELD, COUNTY OF ESSEX, STATE OF NEW JERSEY

WHEREAS, the Mayor and Township Council wish to establish an advisory committee for the purpose of having community representatives serve in an advisory capacity and provide recommendations regarding the cultural assets of the Township of Bloomfield, including Oakeside Mansion and Collins House.

NOW, THEREFORE BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

**Section 1.** Chapter 5, "ADMINISTRATION OF GOVERNMENT," Part 6. Additional Committees, Boards and Commissions, of the Code of the Township of Bloomfield, County of Essex, State of New Jersey, is hereby amended to establish the following:

**ARTICLE XXVI "Bloomfield Cultural Preservation Advisory Committee,"**

§5-139. Bloomfield Cultural Preservation Advisory Committee.

- A. There shall be a Bloomfield Cultural Preservation Advisory Committee.
- B. The Committee shall consist of five (5) residents of the Township, each of whom shall be appointed by the Mayor and shall have full member voting rights, and one (1) Township Council liaison who shall be a non-voting member. The Director of Cultural Preservation shall serve as ex-officio member and shall not have voting rights.
- C. Terms shall be staggered; 2 members shall be appointed for terms of one (1) year, 1 member shall be appointed for terms of two (2) years, and 2 members shall be appointed for terms of three (3) years. The Council Liaison shall be appointed to a term of one (1) year.

- D. Upon the expiration of a committee member's initial term under this section, the Mayor shall either reappoint that committee member or appoint his/her replacement for a term of either 1, 2, or 3 years. No member shall serve on the committee longer than six (6) consecutive years.
- E. Vacancies shall be filled by the Mayor only for the unexpired term.
- F. The Committee shall meet at least quarterly.
- G. The members of this Committee shall not receive compensation for their services.

§5-140 Powers and duties.

The Committee will advise the Director, as well as Mayor and Council, regarding the strategic direction and policies for the Township of Bloomfield's cultural assets, including but not limited to Oakeside Mansion and Collins House. The Committee will be advisory in capacity and will not be responsible for budget, operations, programing, or fundraising, but may consult with Township Staff and Officials as needed and/or requested.

**Section 2.** All ordinances inconsistent herewith are hereby repealed.

**Section 3.** This ordinance shall take effect upon final passage and publication in accordance with the law.
