2022 ORDINANCE NEW ORDINANCE

AN ORDINANCE TO AMEND CHAPTER 5, "ADMINISTRATION OF GOVERNMENT," Part 2. Officers and Employees, ARTICLE V "Township Administrator," IN THE CODE OF THE TOWNSHIP OF BLOOMFIELD, COUNTY OF ESSEX, STATE OF NEW JERSEY

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 5, "ADMINISTRATION OF GOVERNMENT," Part 2. Officers and Employees, ARTICLE V "Township Administrator," in the Code of the Township of Bloomfield, County of Essex, State of New Jersey, is hereby amended to change the following:

§5-39A-1. Establishment of Division of Cultural Preservation; division head.

- A. Within the Office of the Township Administrator, there shall be a Division of Cultural Preservation ("Division"), the head of which shall be the Director of Cultural Preservation ("Director").
- B. The Director shall be an unclassified position and he/she shall, prior to appointment, be qualified by training and experience for the duties of the office.

§5-39A-2. Powers and Duties of Director of Cultural Preservation.

The Director of Cultural Preservation shall:


- A. Supervise and manage Township cultural facilities that are owned, leased, or operated by the Township of Bloomfield ("Facilities").
- B. Develop, plan and coordinate events and programming for the provision of public art, art projects and cultural activities at the Facilities.
- C. Advise and make recommendations to the Township Administrator and/or Governing Body for Division policy.
- D. Serve as Ex-Officio Member of the Cultural Preservation Advisory Committee.

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.




