2022 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

- (642) 12 Tunbridge Place 2nd Floor, starting at a point 160 feet West of the Southern curb line of Ampere Parkway running 20 feet North therefrom. (Placard #P2115246)
- (643) 138 North 17th Street, starting at a point 280 feet North of the Westerly curb line of First Avenue running 20 feet North therefrom. (Placard P2306968)
- (644) 204 Ampere Parkway, starting at a point 60 feet North of the Easterly curb line of Abington Avenue running 20 feet North therefrom. (Placard P2201842)
- (645) 24 Van Winkle, starting at a point 345 feet East of the Northern curb line of Davey Street running 20 feet North therefrom. (Placard P2317489)
- (646) 214 Ampere Parkway 2nd Floor, starting at a point 200 feet North of the Easterly curb line of Abington Avenue running 20 feet North therefrom. (Placard P2234118)
- (647) 22 Franklin Street 2nd Floor, starting at a point 95 feet North of the Westerly curb line of Franklin Street running 20 feet North therefrom. (Placard P2255775)
- (648) 236 North 16th Street, starting at a point 128 feet North of the Easterly curb line of Beardsley Avenue running 20 feet North therefrom. (Placard P2410483)


Section 2. All ordinances inconsistent herewith are hereby repealed.


