2022 ORDINANCE NEW ORDINANCE

AN ORDINANCE ESTABLISHING CHAPTER 5, "ADMINISTRATION OF GOVERNMENT," Part 6. Additional Committees, Boards and Commissions, ARTICLE XXVII "Juneteenth Holiday Advisory Committee," IN THE CODE OF THE TOWNSHIP OF BLOOMFIELD, COUNTY OF ESSEX, STATE OF NEW JERSEY

WHEREAS, the Mayor and Township Council wish to establish an advisory committee for the purpose of having community representatives serve in an advisory capacity to provide recommendations and advise the Township on building a culture of awareness and organizing events celebrating the Juneteenth national holiday.

NOW, THEREFORE BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 5, "ADMINISTRATION OF GOVERNMENT," Part 6. Additional Committees, Boards and Commissions, of the Code of the Township of Bloomfield, County of Essex, State of New Jersey, is hereby amended to establish the following:

ARTICLE XXVII "Juneteenth Holiday Advisory Committee,"

§5-141. Bloomfield Juneteenth Holiday Advisory Committee.

- A. There shall be a Bloomfield Juneteenth Holiday Advisory Committee.
- B. The Committee shall consist of five (5) residents of the Township, each of whom shall be appointed by the Mayor and shall having full member voting rights, and one (1) Township Council liaison who shall be a non-voting member.
- C. Terms shall be staggered; 2 members shall be appointed for terms of one (1) year, 1 member shall be appointed for terms of two (2) years, and 2 members shall be appointed for terms of three (3) years. The Council Liaison shall be appointed to a term of one (1) year.
- D. Upon the expiration of a committee member's initial term under this section, the Mayor shall either reappoint that committee member or appoint his/her replacement for a term of either 1, 2, or 3 years. No member shall serve on the committee longer than six (6) consecutive years.

- E. Vacancies shall be filled by the Mayor only for the unexpired term.
- F. The Committee shall meet at least quarterly.
- G. The members of this Committee shall not receive compensation for their services.

§5-142 Powers and duties.


The duty and function of the Committee shall be to advance, through community effort or otherwise, education, cultural awareness, and celebration among the community and to make recommendations to the Mayor and Township Council for the development of programs of formal and informal education that will aid in building recognition and appreciation of this national holiday. Specifically, the Committee is charged with fostering good will and cooperation throughout the community by holding events and educational programs and participating in and organizing like-minded activities to educate the public. The Committee will be advisory in capacity and will not be responsible for budget, operations, programing, or fundraising, but may consult with Township Staff and Officials as needed and/or requested.

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.


