**2022 ORDINANCE AMENDMENT**

**AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS**

**BE IT ORDAINED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:


- (649) 36 Columbus Street, starting at a point 60 feet South of the Southern curb line of Bay Avenue running 20 feet North therefrom. (Placard #P1894264)
- (650) 76 State Street, starting at a point 117 feet South of the Southern curb line of Park Avenue running 20 feet North therefrom. (Placard P2363641)
- (651) 210 Franklin Street, starting at a point 117 feet East of the Easterly curb line of Berkeley Place running 20 feet East therefrom. (Placard P2588569)
- (652) 24 Alfred Lane, starting at a point 356 feet East of the Easterly curb line of Donald Street running 20 feet East therefrom. (Placard P2442563)
- (653) 9 Beekman Street, starting at a point 115 feet East of the Easterly curb line of East Passaic Avenue running 20 feet East therefrom. (Placard P2582392)
- (654) 31 Watsessing Avenue, starting at a point 225 feet West of the Westerly curb line of Westinghouse Plaza running 20 feet East therefrom. (Placard P2386640)

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.


