AN ORDINANCE TO AMEND CHAPTER 217, "Fees" WITHIN THE TOWNSHIP CODE OF THE TOWNSHIP OF BLOOMFIELD (Oakeside Mansion)

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, that Chapter 217 Fees shall be amended by creating Article VII, "Oakeside" which shall read as follows:

Section 1. Chapter 217 "Fees", Article VII Oakeside Mansion", § 217-19, "Fees", of the Code of the Township of Bloomfield, County of Essex, State of New Jersey, is hereby amended by the addition of the following:

Four (4) Hours or less

Single Room (Interior)	\$200	\$250
Porch or Great Lawn	\$250	\$313
Commercial Photography	\$500	\$625

Eight (8) Hours or less


