2022 ORDINANCE AMENDMENT

ORDINANCE AMENDING CHAPTER 5, "ADMINISTRATION OF GOVERNMENT", PART 3, ARTICLE X, "DEPARTMENT OF HEALTH AND WELFARE"

WHEREAS, the Township of Bloomfield has a Department of Health and Welfare (**the "Department"**), under the direction of an experienced Director, qualified Health Officer, and competent staff; and

WHEREAS, there is a Board of Health (**the "Board"**), authorized by N.J.S.A. 26:3-1 and the Code of the Township of Bloomfield, the members of which are to be appointed by the Township Council; and

WHEREAS, pursuant to N.J.S.A. 26:3-10, "The local board in every township having a population of more than twenty thousand inhabitants shall be composed of not less than five nor more than seven members..."; and

WHEREAS, the Mayor and Council wish to increase the composition of the Board from five to seven members, in conformity with the aforementioned statute.


NOW, THEREFORE BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield as follows:

Section 5-64. Enumeration of divisions; appointment of Local Health Officer and Director of Welfare.

- A. There shall be two divisions within the Department of Health and Welfare, as follows:
 - (1) Division of Health, which shall consist of a Board of Health of seven members, to be appointed by the Township Council of the Township of Bloomfield for the terms provided by the Charter, this Code and other Township ordinances, and the Local Health Officer and the officers and employees of the Division and a member of the Township Council of the Township of Bloomfield; the municipal liaison shall serve for a period of one year and shall not be entitled to vote at any meeting of the Board.


