2024 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND CHAPTER 254, "VEHICLES AND TRAFFIC", by ARTICLE VI "Schedules" § 254-62 "Schedule XXII: Bus Stops."

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 254 "Vehicles and Traffic", ARTICLE VI "Schedules", § 254-62 "Schedule XXII: Bus Stops." of the Code of the Township of Bloomfield, County of Essex, State of New Jersey, is hereby amended to include bus stops at the following locations:

| Name of Street | Side | Location |
|---------------------|-------|---|
| Broad Street | North | Beginning at the easterly curb line of Highfield Road and extending 105 feet easterly therefrom |
| West Passaic Avenue | East | Beginning at the northerly curb line of Lindberg Boulevard and extending 100 feet northerly therefrom |
| West Passaic Avenue | East | Beginning at the southerly curb line of Barnett Avenue and extending 105 feet southerly therefrom |

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.




