**2024 ORDINANCE AMENDMENT**

---

**AN ORDINANCE TO AMEND THE TOWNSHIP OF BLOOMFIELD'S ORDINANCE ADOPTING TITLES FOR EMPLOYEES AND FIXING SALARY RANGES (Bloomfield Fire Superior Officers 2021 to 2025)**

**WHEREAS**, the Township of Bloomfield has entered into a Collective Bargaining Agreement with the Bloomfield Fire Superior Officers Association; and

**WHEREAS**, the Collective Bargaining Agreement sets forth the terms and conditions of employment including the salaries of the employees of the Bloomfield Fire Superior Officers Association, for January 1, 2021 through December 31, 2025; and

**WHEREAS**, the Director of Finance has indicated that there are sufficient funds within the Township of Bloomfield's budget to cover the costs of salaries and benefits contained within the Collective Bargaining Agreement; and

**WHEREAS**, the Director of Finance has reviewed the salary rates set forth below for the titles listed and certifies that they are accurate; and

**WHEREAS**, it is necessary to amend the Township of Bloomfield salary ordinance to reflect the salaries contained within the Collective Bargaining Agreement.

**BE IT ORDAINED**, by the Mayor and Council of the Township of Bloomfield, New Jersey, that the Township of Bloomfield ordinance adopting titles for employees and fixing salary ranges is hereby amended and supplemented so that the same shall read as follows:

**SECTION 1.** Effective January 1, 2021, as hereinafter indicated, the salaries of certain officers and members of the Fire Department of the Township of Bloomfield are hereby



Also, the base pay without the Holiday Pay/Senior Officers stipend will be used for the calculation of overtime, acting officer pay and terminal leave.

**SECTION 3** All ordinances inconsistent herewith are hereby repealed.

**SECTION 4** This ordinance shall take effect according to law.


