2024 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

- (750) 718 Broad Street, West curb, starting at a point 356 feet South of the Southerly curb line of Glen Ridge Parkway running 20 feet South therefrom. Placard # P2787581
- (751) 1 Alfred Lane, South curb, starting at a point 100 feet East of the Easterly curb line of Donald Street and running 20 feet East therefrom. (Apt. A) Placard # P2564780
- (752) 110 Birch Street, South curb, starting at a point 161 feet West of the Westerly curb line of Broughton Avenue and running 20 feet West therefrom. Placard #2782560
- (753) 16 Stone Street, North curb, starting at a point 170 feet East of the Easterly curb line of Broughton Avenue and running 20 feet East therefrom. Placard #2851278
- (754) 44 Prospect Street, West curb, starting at a point 149 feet North of the Northerly curb line of Willow Street and running 20 feet North therefrom. (Apt. 1) Placard #2790638
- (755) 42 Dodd Street, North curb, starting at a point 28 feet West of the Westerly curb line of Hinrichs Place and running 20 feet West therefrom. (Apt. B) Placard 2679060
- (756) 108 Warwick Street, East curb, starting at a point 163 feet South of the Southerly curb line of Abington Avenue and running 20 feet South therefrom. Placard # 2889326
- (757) 515 Beardsley Avenue, North curb, starting at a point 237 feet West of the Westerly curb line of La France Avenue and running 20 feet West therefrom. Placard #2735006

Section 2. All ordinances inconsistent herewith are hereby repealed.


