AN ORDINANCE TO AMEND CHAPTER 134, "GENERAL ANIMAL REGULATIONS", IN THE CODE OF THE TOWNSHIP OF BLOOMFIELD, ESSEX, COUNTY, NEW JERSEY

WHEREAS, it is necessary from time to time to update the Township ordinances to reflect current economic conditions; and

WHEREAS, there has been a notable increase in fair market price for certain goods and services in New Jersey; and

WHEREAS, costs of maintaining animals in the Animal Control Shelter has risen; and

WHEREAS, there have been circumstances from time to time when a waiver of fees is appropriate; and

WHEREAS, the administration of the Animal Control Shelter need to have the flexibility to accommodate certain individuals experiencing financial distress; so now let it

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows that Section 21, Chapter 134, "General Animal Regulations", is hereby amended and supplemented as follows

§134-21 *Service Fees*


- D. Animal holding fee:
 - (1) Days one through seven, each day: \$20.
 - (2) Days eight and up, each day: \$40.
- E. Fee Waiver. Under special circumstances, management of the animal control center may waive or reduce fees, which would include, but not be limited to adoptions, boarding, reclaims, surrenders, and other actions.

NOW, THEREFORE, BE IT FURTHER ORDAINED that:

1. Ordinances, resolutions and regulations or parts of ordinances, resolutions and regulations inconsistent herewith are hereby repealed to the extent of such inconsistency; and
2. If any section, subsection, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by a court of competent jurisdiction, such a decision shall not affect the remaining portion of the Ordinance; and
3. Except as hereby amended, the Code of the Township of Bloomfield shall remain in full force and effect.
4. This Ordinance shall take effect twenty days after final passage and publication in accordance with law.


