2024 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

- (762) 26 Seely Terrace, East curb, starting at a point 427 feet Northwest of the Westerly curb line of East Passaic Ave running 20 feet North therefrom. Placard # P2883387
- (763) 192 Newark Avenue, South curb, starting at a point 197 feet East of the Easterly curb line of West Street and running 20 feet East therefrom. Placard # P2604683
- (764) 10 Stockton Street, West curb, starting at a point 125 feet North of the Northerly curb line of Montgomery Street and running 20 feet North therefrom. Placard #P2531002
- (765) 99 Thomas Street, East curb, starting at a point 157 feet North of the Northerly curb line of Henry Street and running 20 feet North therefrom. Placard #2845463
- (766) 211 Newark Avenue, North curb, starting at a point 51 feet West of the Westerly curb line of West Street and running 20 feet West therefrom. Placard # 2901000
- (767) 178 Garner Avenue, North curb, starting at a point 171 feet West of the Westerly curb line of Garrabrant Avenue and running 20 feet West therefrom. Placard # 2837568

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.


