**RESOLUTION APPROVING LAN ASSOCIATES AS QUALIFIED REDEVELOPMENT ARCHITECTURAL ENGINEERING CONSULTANT FOR THE RENDERING OF SERVICES TO THE TOWNSHIP OF BLOOMFIELD FOR 2025**

**WHEREAS**, The Township of Bloomfield, has an ongoing need to contract with qualified Architectural Engineer Consultants in the State of New Jersey for the provision of said services for the Township; and

**WHEREAS**, the Township has publicly advertised via the Request of Qualifications (RFQ) process for such Architectural Engineering Consultant; and

**WHEREAS**, the Township has reviewed the Statements of Qualifications submitted in response to the Township RFQ; and

**WHEREAS**, the Township pursuant to the responses to the RFQ, now proposes to qualify LAN Associates to be eligible to serve as Architectural Engineer Consultant and eventually enter into a professional services contract; and

**WHEREAS**, the Director of Finance shall certify that the availability of the funds to pay such contract for Architectural Engineer Consultant when such services are supplied to the Township;

**WHEREAS**, said Architectural Engineer Consultant contract may be awarded without public bidding as a professional services in accordance with N.J.S.A.40A:11-5(a) of the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq. on condition that a resolution authorizing such contracts without competitive bidding and the contracts themselves be made available for public inspection.



1. That the Township of Bloomfield, hereby authorized, a Architectural Engineer Consultant, to enter into professional services contracts with LAN Associates for the provision of legal services during the calendar year 2025.
2. That the Township of Bloomfield is authorized to contract with this Architectural Engineer Consultant for the provision of qualified Architectural Engineer Consultant, subject to Governing Body approval, without competitive bidding in accordance with N.J.S.A. 40A:11-5(1)(A) of the Local Public Contracts Law.


