**THE 2025 AWARD OF A CONTRACT FOR FIRE AND POLICE DEPARTMENT TOWNSHIP SOFTWARE SUPPORT SERVICES AND WEB-BASED TRAINING WITH LEXIPOL.-UNDE STATE CONTRACT # 011822-LXP**

**WHEREAS**, the Township of Bloomfield Fire and Police Department needs the services of professional support for their Web-based Police and Fire Learning Platform services; and

**WHEREAS**, in accordance with N.J.S.A., 40A:11-1 et seq., "Local Public Contracts Law," the Township may, without advertising for bids, purchase any goods or services under a contract entered into on behalf of the State of New Jersey and through specified federal procurement programs, and

**WHEREAS**, the Township Police Chief and Fire Chief have determined that the value of these services will exceed \$17,500; and

**WHEREAS**, LEXIPOL, located at 2611 Internet Boulevard, Suite 100, Frisco, TX 75034, was awarded a state contract # 011822-LXP; and

**WHEREAS**, LEXIPOL, has submitted proposal Invoice # INVLEX11247699, dated February 1, 2025, for \$12,805.39, and Invoice # INVLHI11246165, for the total of \$25,728.44, and Invoice # INVLHI11246164, for a total amount of \$47,347.49; and

**WHEREAS**, the Director of Finance has certified that funds are available to cover the cost of this service in an amount not to exceed \$47,347.49 in account# 5-01-20-140-026; and

**BE IT FURTHER RESOLVED**, that no minimum payment is implied or guaranteed; and

**NOW, THEREFORE, BE IT RESOLVED** that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, hereby accepts the recommendation of the Township Police Chief and Fire Chief and authorize the Assistant Township Administrator / IT Director to contract

with Lexipol for the services of professional support for their Web-based Police and Fire
