2025 RESOLUTION AWARD OF CONTRACT

2025 RESOLUTION - AWARD OF CONTRACT FOR MILBANK PARK
LANDSCAPE MAINTENANCE

WHEREAS, after the required legal advertising was published, sealed bids for Milbank Park Landscape Maintenance Contract were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on Thursday, January 30th at 11:00am by the Township Clerk in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law"; and

WHEREAS, a total of seven (7) bids were received and were referred to the Township Director of Recreation for review; and

WHEREAS, lowest responsive and responsible bid was submitted by Watch Us Grow Landscape Design, Inc. 190 Veterans Drive, Suite 202, Northvale, NJ 07647 for a total price, including Alternate A and B of an amount of \$3,975.00; and

WHEREAS, the bids were reviewed by the Director of Recreation and found to be complete and responsive; and

WHEREAS, the Director of Recreation is recommending a contract be awarded for a twelve (12) month period with options for two (2) additional twelve month extensions if agreeable to both the vendor and Township of Bloomfield; and

WHEREAS, the Director of Finance has indicated that funding is available in account #5-01-28-375-024.

NOW THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Director of Recreation and he may enter into a contract for the Milbank

Park Landscape Maintenance with by Watch Us Grow Landscape Design, Inc. 190 Veterans Drive, Suite 202, Northvale, NJ 07647 for a total price, including Alternate A and B, in an amount not to exceed \$3,975.00 for a twelve (12) month period with the option for two (2) additional twelve month contract extensions.
