**2025 RESOLUTION - SANITARY SEWER INSPECTION - WASHINGTON STREET-  
CHANGE ORDER NO. 1 - FINAL**

**WHEREAS**, the Township of Bloomfield entered into a contract for inspection of a 24-inch sewer main under the portion of Washington Street between Bloomfield Avenue and Franklin Street with National Water Main Cleaning Co., 1806 Newark Turnpike, Kearny, NJ 07032 in the amount of \$37,300.00; and

**WHEREAS**, the contract has been completed; and

**WHEREAS**, during the course of the project, it was necessary to adjust or modify the amount of construction items to account for unforeseen site conditions; and

**WHEREAS**, the final contract amount represents a reduction in the total cost of the contract by \$12,649.10; and

**WHEREAS**, the Mayor and Council, based on the recommendation of the Township Engineer, is satisfied that the specified changes should be approved; and

**WHEREAS**, this Change Order was found to be beneficial and necessary.

**NOW THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Township Of Bloomfield, County of Essex, State of New Jersey that Change Order No. 1 - Final is hereby approved and the Finance Officer of the Township of Bloomfield is hereby authorized to adjust payment for this work in Sewer Capital Account No. C-04-55-232-902.





**WHEREAS**, the final contract amount represents a reduction in the total cost of the contract by \$5,000.00; and


**WHEREAS**, the Mayor and Council, based on the recommendation of the Township Engineer, is satisfied that the specified changes should be approved; and




