**2025 RESOLUTION CHANGE ORDERS**

**2025 RESOLUTION - 2022 CDBG ROADWAY PROGRAM - CHANGE ORDER NO. 2 - FINAL**

**WHEREAS**, the Township of Bloomfield entered into a contract with Stanziale Construction, PO Box 2597, Bloomfield, NJ for the 2022 CDBG Roadway Program for a total contract amount of \$457,230.25, which includes previous Change Order No.1; and

**WHEREAS**, during the course of the work, there were a number of adjustments made to the final contract quantities to account for unforeseen site conditions; and

**WHEREAS**, these changes have resulted in a reduction to the final contract cost of \$32,330.91 or 7.1 percent; and


**WHEREAS**, it is the recommendation of the Township Engineer that the Change Order be approved; and

**WHEREAS**, this work was determined to be necessary and beneficial.




