**2025 RESOLUTION - 2023 CAPITAL ROADWAY PROGRAM - CHANGE ORDER NO. 1 - FINAL**

**WHEREAS**, the Township of Bloomfield entered into a contract with Cifelli & Son, 4 Coppola Street, Nutley, NJ 07110 for the 2023 Capital Roadway Program in the amount of \$668,307.75; and

**WHEREAS**, during the course of the work, there were a number of adjustments made to the final contract quantities to account for unforeseen site conditions; and

**WHEREAS**, these changes have resulted in a reduction to the final contract cost of \$2,587.26; and


**WHEREAS**, it is the recommendation of the Township Engineer that the Change Order be approved; and


