AN ORDINANCE AMENDING CHAPTER 5, "ADMINISTRATION OF GOVERNMENT," Part 6. Additional Committees, Boards and Commissions, ARTICLE XXVII "Juneteenth Holiday Advisory Committee," IN THE CODE OF THE TOWNSHIP OF BLOOMFIELD, COUNTY OF ESSEX, STATE OF NEW JERSEY

WHEREAS, the Mayor and Township Council have established a Juneteenth Holiday Advisory Committee, and now wish to enlarge the Committee's membership.

NOW, THEREFORE BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, Section 1. Chapter 5, "ADMINISTRATION OF GOVERNMENT," Part 6. Additional Committees, Boards and Commissions, of the Code of the Township of Bloomfield, County of Essex, State of New Jersey, is hereby amended as follows:

ARTICLE XXVII "Juneteenth Holiday Advisory Committee,"

**§5-141. Bloomfield Juneteenth Holiday Advisory Committee.**

- A. There shall be a Bloomfield Juneteenth Holiday Advisory Committee.
- B. The Committee shall consist of eight (8) residents of the Township, each of whom shall be appointed by the Mayor and shall have full member voting rights, and one (1) Township Council liaison who shall be a non-voting member.
- C. Terms shall be staggered; 3 members shall be appointed for terms of one (1) year, 3 members shall be appointed for terms of two (2) years, and 2 members shall be appointed for terms of three (3) years. The Council Liaison shall be appointed to a term of one (1) year.
- D. Upon the expiration of a committee member's initial term under this section, the Mayor shall either reappoint that committee member or appoint his/her replacement for a term of either 1, 2, or 3 years. No member shall serve on the committee longer than six (6) consecutive years.
- E. Vacancies shall be filled by the Mayor only for the unexpired term.
- F. The Committee shall meet at least quarterly.


G. The members of this Committee shall not receive compensation for their services.

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.




