2025 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS (removal)

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4,

"Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the deletion of the following:

88 Hill Street, South Curb, starting at a point 526 feet east of the easterly curb line of Orange Street and running 20 feet east therefrom

94 Ella Street, West curb, Starting at a point 368 feet from the southerly curb line of Bloomfield Avenue and 20 feet north therefrom

209 Watsessing Avenue, East Curb, starting at a point 193 feet south of the southern curb line of Grove Street and running 20 feet south therefrom

11 Salter Place, West curb, starting at a point 251 feet north of the northerly curb line of Franklin Street and running 20 feet north therefrom

22 Van Winkle Street Apt C, North curb, starting at a point 324 feet east of the easterly curb line of Davey Street running 20 feet east therefrom (Placard No. P2433363)

8 Donald Street Apt C, West Curb, starting at a point 247 feet north of the northerly curb line of Davey Street and running 20 feet north therefrom

119 Lexington Avenue, starting at a point 164 feet north of the northern curb line of Fontaine Avenue running 20 feet north therefrom (Placard No. P2562779)

67 Franklin Street, North curb, starting at a point 49 feet west of the westerly curb line of Harrison Street and running 20 feet west therefrom

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.
