RESOLUTION: 2025 AWARD OF CONTRACT TO ISLAND TECH FOR OUTFITTING FOUR POLICE VEHICLES UNDER NEW JERSEY STATE CONTRACT NO. 17-FLEET-00744

WHEREAS, the Bloomfield Police Department needs the ability to purchase Materials and Equipment and Installation for the outfitting of four police vehicles; and

WHEREAS, in accordance with N.J.S.A., 40A:11-1 et seq., "Local Public Contracts Law," the Township may, without advertising for bids, purchase any goods or services under a contract entered into on behalf of the state and through specified federal procurement programs; and

WHEREAS, Island Tech, located at 46 4th St, Somerville, NJ 08876, was awarded New Jersey State Contract No. 17-Fleet-00744; and

WHEREAS, Island Tech will provide the Materials and Equipment and Installation for the outfitting of four police vehicles; and

WHEREAS, the Police Chief has determined that the value of these services will exceed \$17,500; and

WHEREAS, the Director of Finance has indicated that funds are available to cover the cost of these services in the amount of \$82,464.00 from account #5-01-25-240-051.

WHEREAS, that no minimum payment is implied or guaranteed.

NOW, THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, hereby accepts the recommendation of the Police Chief and authorizes the Police Chief to contract with Island Tech

for the Materials and Equipment and Installation for the outfitting of four police vehicles not to

exceed \$82,464.00 as needed with Island tech, as described herein.
