RESOLUTION: AUTHORIZING THE PURCHASE OF 3 NEW 2025 FORD UTILITY POLICE INTERCEPTORS AWD AND 1 NEW 2024 FORD UTILITY POLICE INTERCEPTORS AWD FOR THE BLOOMFIELD POLICE DEPARTMENT UNDER THE CRANFORD CO-OP PRICING CONTACT #24-01

WHEREAS, the Township of Bloomfield wishes to purchase three (3) new 2025 Ford utility police interceptors AWD and one (1) new 2024 Ford utility police interceptor AWD and has confirmed the price under the Cranford Co-Op Pricing Contract #24-01 : Police and Administrative vehicles (2024-2025 Model Year)

WHEREAS, the Township Administrator has certified in writing that the value of the service will exceed \$17,500; and

WHEREAS, the police chief has requested that the Township purchase three (3) new 2025 Ford utility police interceptors AWD and one (1) new 2024 Ford utility police interceptor AWD for the police Department to replace four police department vehicles; and

WHEREAS, Gentelini Motors has submitted a quote for three (3) new 2025 Ford utility police interceptors AWD and one (1) new 2024 Ford utility police interceptor AWD at a total cost of \$195,475.48; and

WHEREAS, the purchase will be financed through The Bancorp, and the financed amount of \$211,233.55 will be split into three yearly payments of \$70,410.40 per year for 2025, 2026, and 2027 with the annual payments made directly to The Bancorp. And

WHEREAS, the Director of Finance has certified that funds are available in the Operating Budget.

NOW, THEREFORE, BE IT RESOLVED, that the mayor is authorized to and the clerk to attest an agreement to purchase three (3) new 2025 Ford utility police interceptors AWD and one (1) new 2024 Ford utility police interceptor AWD for a total cost not to exceed \$211,233.55.
