2025 ORDINANCE AMENDMENT

Ord 25 21

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS (removal)

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4, "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the deletion of the following:

37 Berkeley Place. Berkeley Place, East curb, starting at a point 95 feet south of the southerly curb line of Lombard Street and running 18 feet north therefrom.

219 North 17th Street. North 17th Street, West curb, starting at a point 58 feet south of the southerly curb line of Beardsley Avenue and running 20 feet south therefrom.

29 Second Street. Second Street, West curb, starting at a point 150 feet south of the southern curb line of Linden Avenue and running 20 feet south therefrom.

21 Oakland Avenue. Oakland Avenue, East curb, starting at a point 239 feet west of the westerly curb line of Montgomery Street and running 20 feet west therefrom.

84 Martin Street. Martin Street, South curb, starting at a point 257 feet east of the eastern curb line of Pleasant Avenue and running 17 feet east therefrom.

39 Beekman Street. Beekman Street, South curb, starting at a point 82 feet west of the westerly curb line of North Spring Street and running 20 feet north therefrom.


39 Barbara Street. Barbara Street, North curb, starting at a point 612 feet from the easterly curb line of Broughton Avenue and running 20 feet east therefrom.

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.




