2025 RESOLUTION - AWARD OF CONTRACT - 2024 NJDOT LOCAL AID PROGRAM - IMPROVEMENTS TO NEWARK AVENUE (LA-2024 MA)

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on May 6, 2025 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law" for the 2024 NJDOT Local Aid Program - Improvements To Newark Avenue (LA-2024 MA); and

WHEREAS, a total of six (6) bids were received and were referred to the Township Engineer for review; and

WHEREAS, after review of the bids it was determined that the lowest responsible bidder is J.A. Alexander, (the "Contractor") 130-158 John F. Kennedy Drive, Bloomfield, NJ 07003 in the amount of \$397,379.82; and

WHEREAS, the Director of Finance has indicated that funding is available through Account No. G-02-40-302-026, which is reimbursable through a 2024 NJDOT Local Aid Grant in the amount of \$521,652.00 (LA-2024 MA).

NOW THEREFORE, BE IT RESOLVED, that the Mayor and Council of the Township Of Bloomfield, County of Essex, State of New Jersey hereby accepts the recommendation of the Township Engineer and he may enter into a contract for the above improvements with J.A. Alexander, (the "Contractor") 130-158 John F. Kennedy Drive, Bloomfield, NJ 07003 in the amount of \$397,379.82.


