2025 RESOLUTION - CHANGE ORDER NO. 1 - 2024-2025 ANNUAL SEWER VIDEO & CLEANING SERVICES

WHEREAS, the Township of Bloomfield entered into a Contract for sewer video and cleaning services with Montana Construction, 80 Contant Avenue, Lodi, New Jersey 07644 (the Contractor) in an amount not to exceed \$100,000.00; and

WHEREAS, at this time, the Contractor is about to exceed \$100,000.00; and

WHEREAS, the Township has been using the Contractor reliably over the past 8 months to assist in finding blockages and collapses within both our sanitary and storm sewers; and

WHEREAS, the Township Engineer is recommending an increase in the contract amount from \$100,000.00 to \$120,000.00 so that they may continue to utilize these services; and

WHEREAS, the Mayor and Council, based on the recommendation of the Township Engineer, is satisfied that the change should be approved; and

WHEREAS, this Change Order was found to be beneficial and necessary; and.


WHEREAS, funding is available in the following accounts:
