**RESOLUTION: APPOINTMENT OF YESSENIA MONTALVO AS A FULL-TIME ASSISTANT VIOLATIONS CLERK EFFECTIVE APRIL 21, 2025**

**WHEREAS**, the Township of Bloomfield issued a Final Notice of Disciplinary Action to Yessenia Montalvo, terminating her from the title of full-time Assistant Violations Clerk on June 1, 2022; and

**WHEREAS**, Ms. Montalvo appealed the Township's termination and other discipline to the Civil Service Commission ("CSC"); and

**WHEREAS**, the CSC upheld one portion of discipline, but reversed the termination and ordered the Township to reinstate Ms. Montalvo to her title with back pay, benefits, and seniority from the effective date of her removal on June 1, 2022 to her reinstatement date of April 21, 2025. The CSC's actions are memorialized in CSC docket numbers 2022-1463 and 2022-3149; and

**WHEREAS**, all eligible accrued Personal Time Off ("PTO") from the removal to the reinstatement date will be added back to her time bank; and

**WHEREAS**, the employee will be placed at the appropriate step based on her seniority and the contract in effect, and

**WHEREAS**, the back pay to which Ms. Montalvo is entitled will be determined separately; and

**WHEREAS**, the Acting Director of Finance has certified that funds are available to make this full-time appointment; and

**WHEREAS**, this is a non-exempt position.


**NOW, THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, that Yessenia Montalvo is hereby appointed to the title

of full-time Assistant Violations Clerk effective April 21, 2025 at step nine of the salary guide in effect


for that position and will be credited for eligible PTO during the reinstatement period.


