Resolution Authorizing Memorandum of Understanding with Essex Health and Wellness Recovery Center to Host Black Poster Project Day

WHEREAS, the Black Poster Project is a traveling exhibit that depicts the devastation of opioid overdose and fentanyl poisoning. New Jersey lost 1,813 people to this epidemic in 2024. The Black Poster Project will spread awareness of the opioid epidemic and help prevent onset use of opioids and other drugs, and


