**RESOLUTION APPOINTING STEVE MARTINO AS ACTING DIRECTOR OF  
LAW EFFECTIVE JULY 15, 2025**

**WHEREAS** the table of organization of the Township of Bloomfield requires the appointment of a Director of Law to perform all of the duties and responsibilities set forth in the Charter of the Township of Bloomfield, its by-laws, ordinances and laws of the State of New Jersey; and

**WHEREAS**, Michael Parlavecchio will have resigned from his position as the Director of Law effective July 25, 2025; and

**WHEREAS**, Steve Martino, the Assistant Director of Law, has undertaken the duties of the Director of Law including during a ten day transition period prior to Michael Parlavecchio's effective resignation date while at the same time continued to perform his duties as Assistant Director of Law; and

**WHEREAS**, Steve Martino is interested in filling the position of Acting Director of Law, in addition to continuing to hold his position as Assistant Director of Law, until the Township fills the position on a permanent basis; and

**WHEREAS** the Mayor and Township Council of the Township of Bloomfield have determined it is in the best interest of the Township to appoint Steve Martino as Acting Director of Law to perform these duties and responsibilities.

**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey that Steve Martino is hereby appointed as the Acting Director of Law, effective July 15, 2025 with a stipend of \$5,662 per month for this

acting role until the appointment of a permanent Director of Law to include a transition period as determined by the Township Administrator. At the conclusion of the transition period, Steve Martino will no longer receive the stipend and remain in the position of Assistant Director of Law.

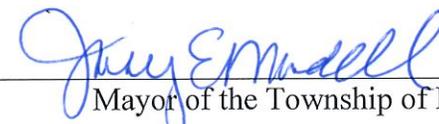
