I have reviewed your permit to install a 19'7 7/8" x 15' 3" first and second floor addition.

Understand that a 25' rear yard setback is required the plans only call for 20.79' and are also missing full plans for me to do the Floor Area Ratio (FAR) calculation.

Please note due to chapter 315:

315-35 Supplementary regulations.

A. General.

(1) No building shall be erected and no existing building shall be moved, altered, added to or enlarged, nor shall any land or building be designed, used or intended to be used for any purpose or in any manner other than as specified among the uses listed as permitted, accessory or conditional in the district in which such building or land is located and in conformance with Schedule A, Bulk and Setback Regulations.^[1]

FLOOR AREA The sum of the area of all floors of buildings measured to the dimensions of the outside walls of the buildings inclusive of ground floor parking, but excluding attics, basements, cellars, sheds and detached garages, except to the extent such areas are finished for use as bedrooms, family rooms, studies or other such living quarters;

open porches, decks, patios, terraces, balconies, breezeways and arcades; utility, mechanical and emergency power equipment areas; stairwells and elevator shafts in commercial buildings and multifamily dwellings; guard houses; and any open area above the ground floor within an open atrium space.

Therefore I cannot approve this application as it requires:

- Bulk variance: does not meet 20' rear yard setback
- Other notes: only 2 sets of plans submitted 3 required (one for zoning, one for building and last for on site) when approved
- Need full floor plans in order to do floor area ratio

All state and Local codes & ordinances shall be strictly adhered to as applies to this work. The International Building Code New Jersey Edition 2021 as adopted by the Township of Bloomfield, New Jersey shall govern this work.

The Contractor shall obtain all necessary permits, licenses, inspections and other legal fees, both permanent and temporary, necessary to execute his work. The contractor for heating, plumbing and electrical shall provide necessary approvals.

The contractor shall verify all conditions before submitting proposal. No allowance for extra charges will be permitted because of lack of knowledge of the conditions peculiar thereto except as otherwise specified elsewhere in the contract documents.

The contractor shall visit the site before accepting a contract for work and shall familiarize himself with the existing conditions. The contractor will notify the Owner or Architect of the problem area.

All dimensions shown on the drawings shall be considered plus or minus until verified. The contractor shall verify all lines and dimensions shown on the drawings and will be held responsible for the correctness and setting out of his work.

The intent of the drawing is to have the Contractor turn over to the Owners a complete and finished job in every manner. The contractor shall leave the job broom clean and shall have carted away all debris and trash caused by the work.

The GC will be responsible for all painting.

The contractor shall provide all labor, materials, appliances and equipment required to complete all work, etc., as shown on drawings necessary for a safe and complete job, unless otherwise specified.

All materials shall be new and of good quality.

The accepted industry standards as applies to workmanship, methods, and quality shall guide the work and be considered acceptable, unless the drawings indicate that a condition or detail be handled in some specific manner.

All questionable aspects of contract documents must be brought to the Architects attention prior to the bid date or contractor waives right for future claims for extra costs.

These general conditions are binding on the General Contractor and each Sub-Contractor insofar as they apply to the work of either.

- For an Addition: Exterior Walls - 5 1/2" wood studs @ 16" O.C. with 1 1/2" Zip R Sheathing on exterior (R-6), w/ R-21 cavity insulation or 3 1/2" wood studs @ 16" O.C. w/ 2" Zip R sheathing on exterior (R-9), w/ R-16 cavity insulation. See Plan. Align w/ exterior surface of existing sheathing if addition is over existing exterior walls unless noted otherwise. In lieu of continuous insul., on the exterior of the wall framing, walls can have an insulation value of R-30 or greater and it not be required.

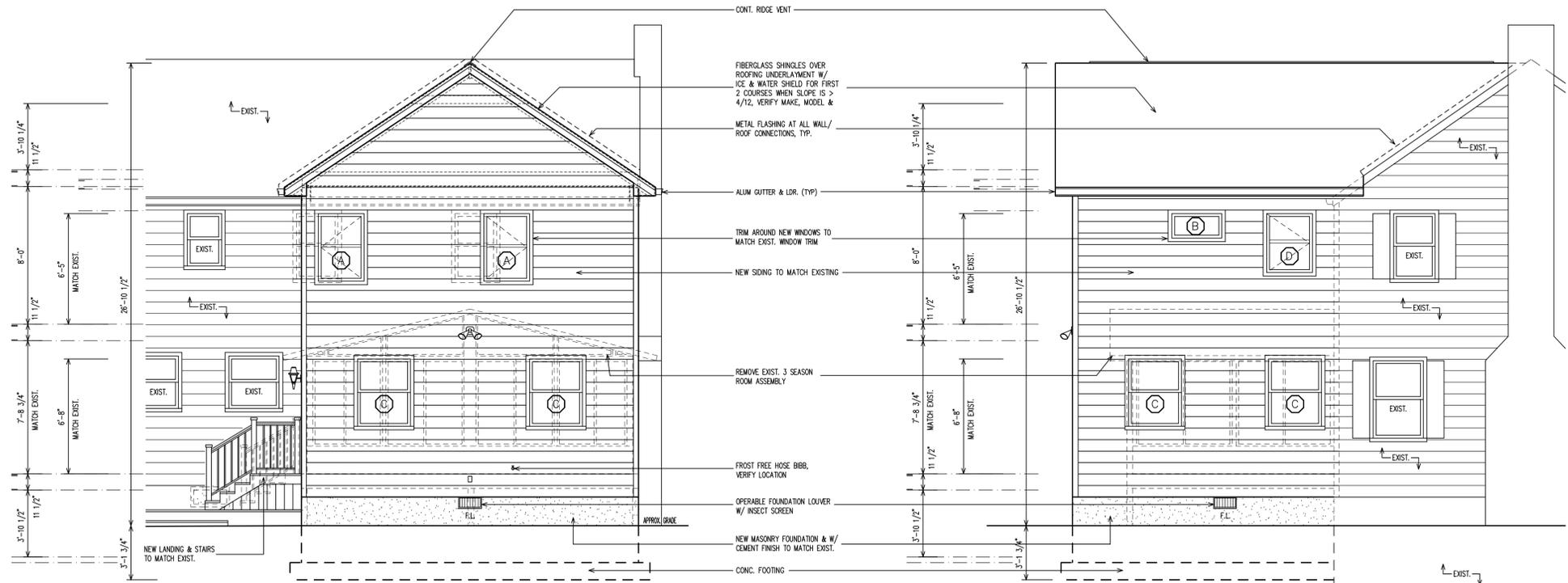

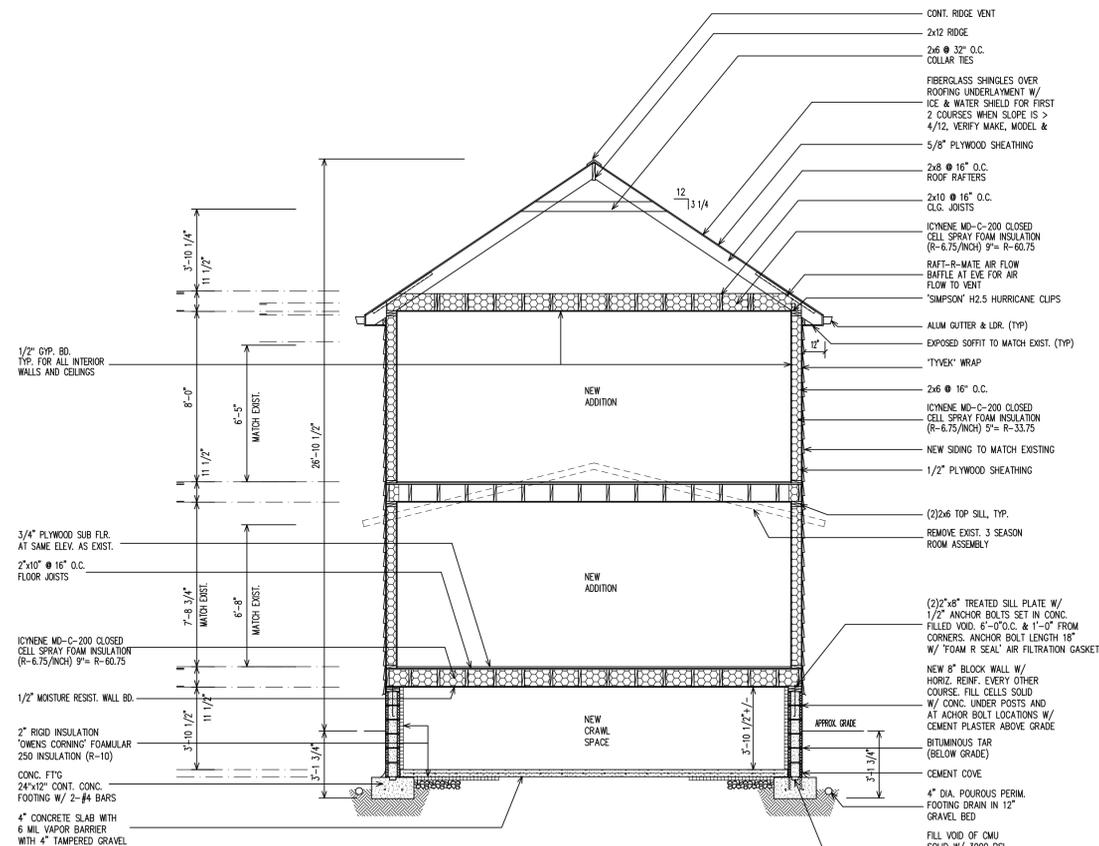


PARTIAL REAR ELEVATION

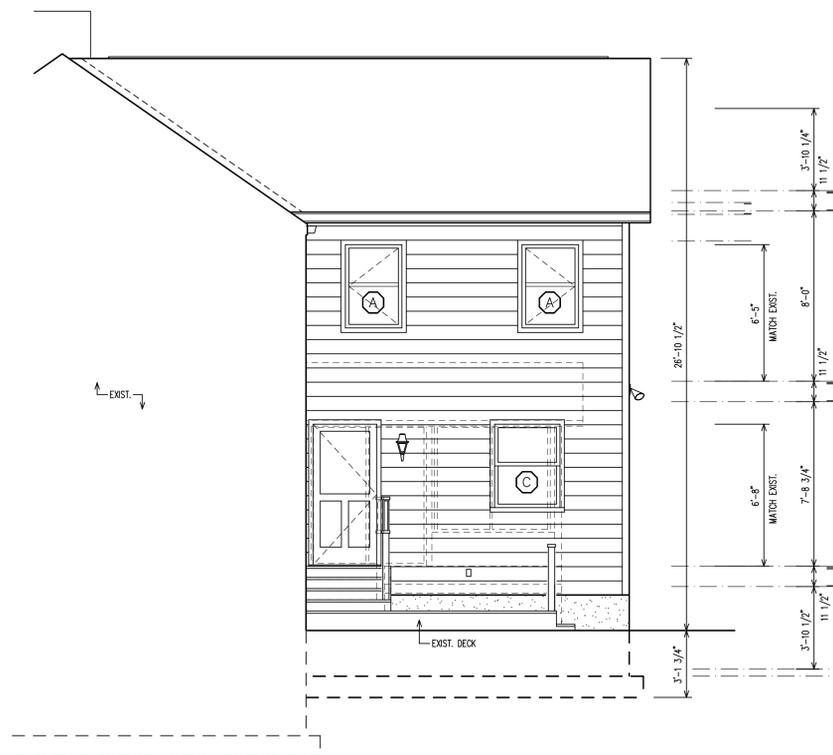
PARTIAL LEFT ELEVATION

Mr. Beese,

We did not measure and document the entire home since we were just doing a rear addition and minor rear alterations. In order to calculate the Floor Area Ratio, the Site plan was used to measure the area of the existing structure and then added the additional area as per the new larger rear addition where the existing enclosed porch was previously located. Below is the data used:

Area of the existing first floor of the house (952 s.f.) + area of the rear enclosed porch (239 s.f.) = 1,191 s.f. existing. The area of the existing second floor is (750 s.f.) for a total existing area of 1,941 s.f. The lot area is 7,071 s.f. $1,941 \text{ s.f.} / 7,071 \text{ s.f.} = .27 \text{ FAR (existing)} < .5 \text{ FAR allowed.}$

The area of the new addition adds 40 s.f. on the first and second floors for a new total area of 2,021 s.f. The lot area is 7,071 s.f. $2,021 \text{ s.f.} / 7,071 \text{ s.f.} = .29 \text{ FAR (proposed)} < .5 \text{ FAR allowed.}$
