RESOLUTION: GOVERNOR'S COUNCIL ON ALCOHOLISM AND DRUG USE DISORDER (GCSUD) - FISCAL GRANT CYCLE JULY 1, 2026 - JUNE 30, 2027

WHEREAS, the Governor's Council on Substance Use Disorder (GCSUD) established the Municipal Alliances for the Prevention of Substance Use Disorder in 1989 to educate and engage residents, local government and law enforcement officials, schools, nonprofit organizations, the faith community, parents, youth and other allies in efforts to prevent substance use disorder in communities throughout New Jersey.

WHEREAS, The Township of Bloomfield Council, County of Essex, State of New Jersey recognizes that substance use disorder is a serious problem in our society amongst persons of all ages; and therefore, has an established Municipal Alliance Committee; and

WHEREAS, the Township of Bloomfield Council further recognizes that it is incumbent upon not only public officials but upon the entire community to take action to prevent substance use disorder in our community; and,

WHEREAS, the Township of Bloomfield Council has applied for funding to the Governor's Council on Substance Use Disorder through the County of Essex;

NOW, THEREFORE, BE IT RESOLVED by the Township of Bloomfield, County of Essex, State of New Jersey hereby recognizes the following:

1. The Township of Bloomfield Council does hereby authorize submission of a strategic plan for the Bloomfield Municipal Alliance grant for fiscal year 2027 in the amount of:

In-Kind	\$11,475
