**AWARD OF CONTRACT - 2026 SNOW PLOWING, REMOVAL & HAULING
 CONTRACT FOR THE TOWNSHIP OF BLOOMFIELD**

WHEREAS, after the required legal advertising was published, sealed bids were received in the Council Chambers of the Municipal Building, Bloomfield, New Jersey on November 12, 2205 by the Purchasing Committee of the Township of Bloomfield in accordance with N.J.S.A. 40A:11-1 et seq., “Local Public Contracts Law” for Snow Plowing and Removal Services for the Township of Bloomfield; and

WHEREAS, two BIDs were received and subsequently referred to the Department of Public Works & Park Maintenance for review; and

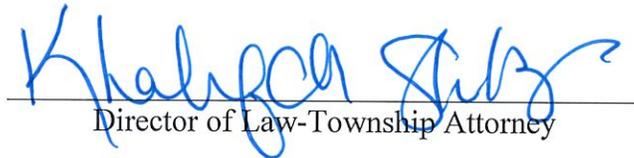

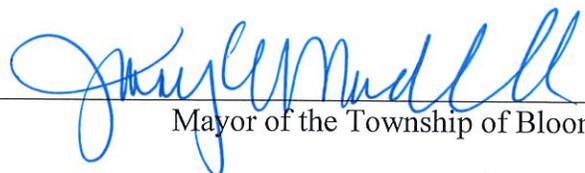
