**2026 RESOLUTION AWARD OF PROFESSIONAL SERVICE** **B2601-03**

**2026 AWARD OF A CONTRACT FOR RADIO TELECOM SUPPORT AND SERVICES WITH NEW JERSEY OFFICE INFORMATION TECHNOLOGY COMMUNICATIONS- NJOIT**

**WHEREAS**, the Township of Bloomfield needs professional support and services for their radio and telecommunication system throughout the Township; and

**WHEREAS**, in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law," the Township may, without advertising for bids, purchase any goods or services under a contract entered into on behalf of the State of New Jersey and through specified federal procurement programs; and

**WHEREAS**, the Police Chief has determined that the value of these services will exceed \$17,500; and

**WHEREAS**, New Jersey Office Information Technology (NJOIT), located at Fiscal Control Bureau, P.O. Box 7068, is an Inter-State Government Agency that can provide such services; and

**WHEREAS**, NJOIT has submitted the first semi-annual statement dated November 4, 2025 for \$10,375.00, and will submit the second annual statement for the total of \$10,375.00; and

**WHEREAS**, the Director of Finance has certified that funds are available in the amount of \$20,750.00 to cover the cost of this service in account# 6-01-20-140-026; and

**BE IT RESOLVED**, that no minimum payment is implied or guaranteed.

**NOW, THEREFORE, BE IT RESOLVED**, that the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, hereby accepts the recommendation of the Police Chief and authorizes the Assistant Township Administrator / IT Director to contract with New Jersey Office Information Technology for the services of radio and telecommunication system throughout the Township not to exceed \$20,750.00, as described herein.
