**2026 AWARD OF CONTRACT TO FIRST PRIORITY EMERGENCY VEHICLES- H-GAC CO-OP CONTRACT #AM10-23 FOR THE PURCHASE OF A 2026 T350 FORD TRANSIT VAN FOR THE TOWNSHIP OF BLOOMFIELD POLICE DEPARTMENT**

**WHEREAS**, the Township of Bloomfield Police Department needs the ability to purchase a 2026 T350 Ford Transit Van,

**WHEREAS**, in accordance with N.J.S.A. 40A:11-1 et seq., "Local Public Contracts Law," the Township may, without advertising for bids, purchase any goods or services under a contract entered into on behalf of the state and through specified federal procurement programs, and

**WHEREAS**, First Priority Emergency Vehicles, located at 160 Gold Mine Rd, Flanders, NJ 07836, was awarded H-GAC CO-OP Contract #AM10-23, and

**WHEREAS**, First Priority Emergency Vehicles will provide a 2026 T350 FORD TRANSIT VAN for the Township of Bloomfield Police Department and

**WHEREAS**, the Township of Bloomfield Police Department has determined that the value of this equipment is \$113,273.22; and

**WHEREAS**, the Director of Finance has indicated that funds are available to cover the cost of these services in account #T-32-56-227-001 Federal Forfeiture Funds.

**NOW, THEREFORE, BE IT RESOLVED** that the Mayor and Council of the Township of Bloomfield, Essex County, New Jersey, hereby accept the recommendation of the Bloomfield Police Department to contract with First Priority Emergency Vehicles to purchase a 2026 Ford Transit T350 van for \$113,273.22.


