2026 ORDINANCE AMENDMENT

Ord 26 2

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

- (773) 141 East Passaic Avenue, West curb, starting at a point 403 feet South of the Southerly curb line of Hoover Avenue and running 20 feet South therefrom. Placard # P3095367
- (774) North 17th Street, East curb, starting at a point 59 feet North of the Northerly curb line of Beardsley Avenue and running 20 feet North therefrom. Placard # P2892240
- (775) 94 Hill Street, East curb, starting at a point 455 feet North of the Northerly curb line of Orange Street and running 20 feet North therefrom. Placard # P2936840
- (776) 11 Salter Place, Apt #2, West curb, starting at a point 260 feet North of the Northerly curb line of Franklin Street and running 20 feet North therefrom. Placard # P3069832
- (777) 17 Stone Street, South curb, starting at a point 280 feet East of the Easterly curb line of Broughton Avenue and running 20 feet East therefrom. Placard # P2693849

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.
