**2019 ORDINANCE AGREEMENTS**

**ORDINANCE OF THE TOWNSHIP OF BLOOMFIELD, COUNTY OF ESSEX, NEW JERSEY APPROVING THE APPLICATION FOR A LONG TERM TAX EXEMPTION AND AUTHORIZING THE EXECUTION OF A FINANCIAL AGREEMENT WITH 110-116 WASHINGTON STREET REALTY URBAN RENEWAL, LLC**

**WHEREAS**, the Local Redevelopment and Housing Law, N.J.S.A. 40A:12A-1 et seq. (the "Redevelopment Law") authorizes municipalities, such as the Township of Bloomfield (the "Township"), to participate in the redevelopment and improvement of areas in need of redevelopment; and

**WHEREAS**, pursuant to the Redevelopment Law, and after investigation and recommendation by the Township Planning Board, the Township designated certain parcels of real property, including the properties then known as Block 220, Lots 26, 27, 30 and 35 on the Township's Official Tax Map, as the Bloomfield Station Redevelopment Area (the "Redevelopment Area"); and

**WHEREAS**, by Ordinance No. 03-34 adopted on October 15, 2003, the Township approved and adopted the Bloomfield Station Redevelopment Plan dated September 2003, as amended from time to time (the "Redevelopment Plan"), which governs the redevelopment of the Redevelopment Area; and

**WHEREAS**, the Township Council duly adopted a resolution designating 110 Washington Street Associates as redeveloper of the portion of the Redevelopment Area then known as Block 220, Lots 26, 27, 30 and 35 on the Township's tax map (now known as Block 220, Lot 26, as the lots were consolidated into one new tax lot known as Block 220, Lot 26) (the "Redevelopment Project Site"); and

**WHEREAS**, 110 Washington Street Associates subsequently formed 110-116 Washington Street Realty Urban Renewal, LLC (the “Entity”), a single-purpose entity owned by the principals of 110 Washington Street Associates for the purpose of redeveloping the Redevelopment Project Site with the Project; and

**WHEREAS**, the Entity intends to redevelop the Redevelopment Project Site by constructing thereon two (2) 5-story buildings containing in the aggregate approximately 170 residential units and 238 parking spaces together with other site improvements (the “Project”); and

**WHEREAS**, the Township and the Entity will enter into a redevelopment agreement (the “Redevelopment Agreement”) to set forth the terms and conditions under which the Entity will construct the Project on the Redevelopment Project Site; and

**WHEREAS**, pursuant to and in accordance with the provisions of the Long Term Tax Exemption Law, N.J.S.A. 40A:20-1 et seq., as amended and supplemented (the “Exemption Law”), the Township is authorized to provide for and accept, in lieu of real property taxes, an annual service charge paid by the Entity to the Township; and

**WHEREAS**, the Entity, an urban renewal entity duly formed and qualified to do business under the provisions of the Exemption Law, submitted an application to the Township pursuant to N.J.S.A. 40A:20-8 (the “Exemption Application”) requesting an exemption of the Project improvements from taxation as provided for therein, and a form of financial agreement (the “Financial Agreement,” a copy of which is appended hereto as Attachment A) establishing the rights, responsibilities and obligations of the Entity pursuant to the Exemption Law; and

**WHEREAS**, the Township Council has determined that the Project represents an undertaking permitted by the Redevelopment Law and Exemption Law, and has further determined that the Project constitutes an urban renewal project for the purposes of clearing, re-

planning, development or redevelopment of an area in need of redevelopment within the Township, as authorized by the Redevelopment Law and the Long Term Exemption Law.

**NOW, THEREOFRE, BE IT ORDAINED** by the Mayor and Council of the Township of Bloomfield, County of Essex, New Jersey as follows:

Section 1. The Exemption Application of the Entity recommended by the Mayor is hereby approved.

Section 2. The Mayor is hereby authorized to execute a Financial Agreement in substantially the form appended hereto as Attachment A, subject to minor modifications or revisions, as deemed necessary and appropriate after consultation with the Township Attorney.

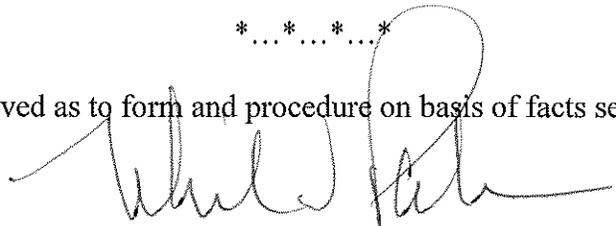
Section 3. The Township Clerk is hereby authorized and directed, upon execution of the Financial Agreement by the Mayor, to attest to the signature of the Mayor and to affix the corporate seal of the Township upon such document.

Section 4. The executed copy of the Financial Agreement shall be certified by and filed with the Township Clerk. Further, the Township Clerk shall file certified copies of this Ordinance and Financial Agreement with the Township Tax Assessor and the Director of the Division of Local Government Services, in accordance with Section 12 of the Exemption Law.

Section 5. This Ordinance shall take effect in accordance with applicable law.

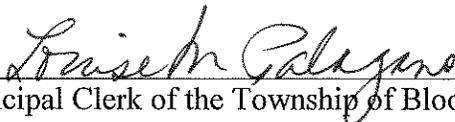
