2019 ORDINANCE AMENDMENT

AN ORDINANCE OF THE TOWNSHIP OF BLOOMFIELD, IN THE COUNTY OF ESSEX, STATE OF NEW JERSEY, DISSOLVING THE BOARD OF RECREATION COMMISSIONERS OF THE TOWNSHIP OF BLOOMFIELD PURSUANT TO N.J.S.A. 40:12-1

WHEREAS, The Township Council of the Township of Bloomfield, in the County of Essex, State of New Jersey (the "Township") created the Department of Recreation, the head of which shall be the Board of Recreation Commissioners (the "Board") by Ordinance, as amended February 2, 1966 and acts amendatory thereof or supplemental thereto, in accordance with the provisions of N.J.S.A. 40:12-1 et seq., and codified as Chapter 5, Part 3, Article XI in the Code of the Township of Bloomfield; and

WHEREAS, after a careful examination and analysis, the Township has determined that it is in the best interests of the residents of the Township and the users of the Department of Recreation to dissolve the Board of Recreation Commissioners; and

WHEREAS, by separate act, the Township has determined it is in the best interests of the residents of the Township to create a Department of Recreation and Cultural Affairs, the head of which shall be the Director of the Department of Recreation and Cultural Affairs (the "Director"), and further establish a Bloomfield Parks, Recreation and Cultural Affairs Advisory Committee to advise the Director; and

WHEREAS, the Township desires to dissolve the Board of Recreation Commissioners with and in fulfillment of the provisions of N.J.S.A. 40:12-1 et seq.

NOW, THEREFORE, BE IT ORDAINED, by the Township Council of the Township of Bloomfield, in the County of Essex, State of New Jersey, as follows:

1. The Board of Recreation Commissioners, created by the Township by ordinance, be and the same is hereby dissolved, subject to the terms and conditions hereof.
2. The Department of Recreation, now known as the Department of Recreation and Cultural Affairs,

shall be headed by the Director.



3. All Powers and Duties previously delegated by ordinance to the Board shall now be delegated to the Director.
4. All ordinances of the Township which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

This ordinance shall take effect immediately upon the adoption hereof and shall not be subject to referendum
