2019 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS (27 Irving Terrace, 64 Park Avenue, 47 Marcy Street, 165 Spruce Street)

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

(579) 165 Spruce Street, east side starting at a point 149 feet north of the northerly curb line of Beach Street and running 20 feet north therefrom

(580) 47 Marcy Street, south curb, starting at a point 92 feet west of the westerly curb line of Curtis Street and running 20 feet west therefrom

(581) 64 Park Avenue, south curb, starting at a point 195 feet west of the westerly curb line of Jersey Street and running 20 feet west therefrom


(582) 27 Irving Terrace, east curb, starting at a point 326 feet south of the southerly curb line of Gillespie Road and running 20 feet west therefrom

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.
