2019 ORDINANCE CREATING A TITLE

AN ORDINANCE TO AMEND CHAPTER 254, "VEHICLES AND TRAFFIC", ARTICLE VI "SCHEDULES" § 254-32.1: "Electric Vehicle Charging Stations."

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 254 "Vehicles and Traffic", Article III, "Schedules", 254-32.1: "Electric Vehicle Charging Stations", of the Code of the Township of Bloomfield, County of Essex, State of New Jersey, is hereby amended to read as follows:

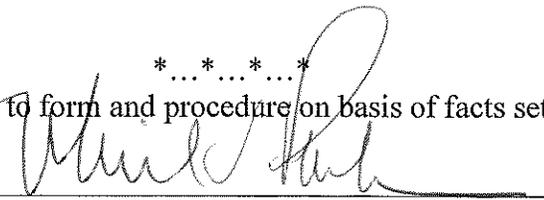
A. Electric Charging Station.

1. The Township Council has provided for Electric Vehicle Charging Stations on and within parking facilities owned by the Township of Bloomfield.
2. No vehicle other than an Electric Vehicle shall park in a Township Electric Vehicle Charging Station.
3. Electric Vehicles parking in a parking space with an electrical charging station shall be required to pay a \$2.00 convenience fee in addition to the parking fee, as set forth by Township ordinance.
4. Violations and Penalties. Any person violating paragraph 2 of this section shall, upon convictions, be subject to a fine of not less than \$100 nor greater than \$250 for each violation.

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.
