2017 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

- (550) Williamson Avenue, east curb, starting at a point 60 feet south of the southerly curb line of
Belleville Avenue and running 20 feet south therefrom (200 Belleville Avenue)
- (551) Broad Street, east curb, starting at a point 211 feet north of the northerly curb line of
Broad Street and running 20 feet north therefrom (347 Belleville Avenue)
- (552) Donald Street, west curb, starting at a point 247 feet north of the northerly curb line of
Davey Street and running 20 feet north therefrom (8c Donald Street)
- (553) Hill Street, west curb, starting at a point 361 feet south of the southerly curb line of
Franklin Street and running 20 feet south therefrom (29 Hill Street)
- (554) Hill Street, south curb, starting at a point 526 feet east of easterly curb line of
Orange Street and running 20 feet east therefrom (88 Hill Street)
- (555) Jefferson Avenue, north curb, starting at a point 171 feet east of the easterly curb line of
LaFrance Avenue and running 20 feet east therefrom (23 Jefferson Avenue)
- (556) Williams Avenue, west curb, starting at a point 307 feet south of the southerly curb line of
West Street and running 20 feet south therefrom (233 Newark Avenue)
- (557) Williamson Avenue, east curb, starting at a point 209 feet north of the northerly curb line
