2018 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND CHAPTER 393, "PARKING, OFF-STREET" ARTICLE II "Permit Parking" § 393-3 Designation of permit parking areas and spaces WITHIN THE TOWNSHIP OF BLOOMFIELD TOWN CODE.

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 393 "Parking, Off-Street" Article II "Permit Parking" § 393-3 Designation of permit parking areas and spaces" of the Code of the Township of Bloomfield, County of Essex, State of New Jersey, is hereby amended to read as follows:

- A. The Township Administrator is hereby authorized to set aside and to designate, in the Glenwood Garage, Conger Street Lot, Farrand Street Lot, Myrtle Street Lot and Pitt Street Lot of the Township, certain parking spaces as permit parking areas.
- B. The Township Administrator, from time to time, shall set aside and designate, in the permit parking areas of the Glenwood Garage, Conger Street Lot, Farrand Street Lot, Myrtle Street Lot and Pitt Street Lot, such number of parking spaces as may be reasonably necessary to accommodate the needs of the public, with regard for the requirements of the public for metered parking spaces.

§393-4. Issuance of Permits.

- A. The Township Administrator, or his/her designee, is hereby authorized to issue to persons applying and qualifying for a parking permit, which shall entitle the holder to park as determined by the Township of Bloomfield Parking Utility.

§393-8. Fees

- A. The fees for the issuance of the aforesaid parking permits shall be as follows:
 - 1. Business Permits - for business owners and their employees in the township who must park within the vicinity of their business all day.

4. Non-Resident Commuter Permits - a limited number of permits are available for commuters who live out of town and wish to park their cars near the available train stations within Bloomfield.

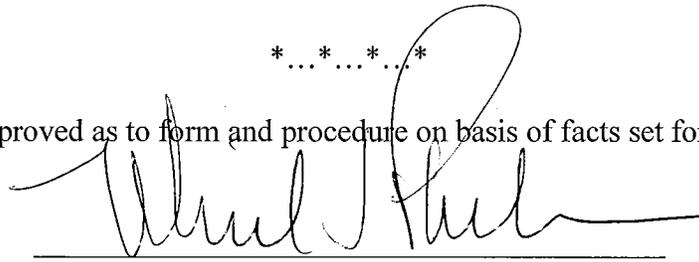
