2018 ORDINANCE AMENDMENT

AN ORDINANCE TO CREATE CHAPTER 491, "SOLID WASTE" ARTICLE II "Recycling" § 491-10 Recycling Committee WITHIN THE TOWNSHIP CODE OF THE TOWNSHIP OF BLOOMFIELD

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 491 "Solid Waste," ARTICLE II "Recycling" § 491-10 Recycling Committee in the Code of the Township of Bloomfield, County of Essex, State of New Jersey, is hereby amending the following section to read as follows:

§ 491-10 Recycling Committee.

A. (1)

(e) One alternate member, who shall reside in the Township of Bloomfield and shall be appointed by the Mayor and Council. The alternate member shall be authorized to vote in the absence of a voting member.

(2) The Recycling Coordinator shall serve at the pleasure of the Mayor and Council; the member of the Council shall serve for a one-year term. Initially, three-voting members shall be appointed to one-year terms, and two at-large members shall be appointed for two-year terms. Thereafter, the terms of all voting members shall be for two years. The alternate member shall be appointed for a two-year term. Three members shall constitute a quorum.

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This amendment shall take effect upon final passage and publication in accordance with the law.
