2018 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND THE TOWNSHIP OF BLOOMFIELD'S ORDINANCE ADOPTING TITLES FOR EMPLOYEES AND FIXING SALARY RANGES (Police Superior Officers)

WHEREAS, the Township of Bloomfield ("Township") has entered into a Collective Bargaining Agreement with the Superior Officers Association- Bloomfield Police Department covering the period January 1, 2017 through December 31, 2020; and

WHEREAS, the Collective Bargaining Agreement ("CBA") sets forth the terms and conditions of employment including salaries of employees in the Superior Officers Association - Bloomfield Police Department; and

WHEREAS, the Township and the Superior Officers Association - Bloomfield Police Department entered into a side letter agreement, which provides for the Township's discretionary appointment of a Deputy Chief of Police position and the compensation for said position; and

WHEREAS, the Director of Finance has indicated that there are sufficient funds within the Township of Bloomfield's budget to cover the costs of salaries and benefits contained within the Side Letter Agreement & the Collective Bargaining Agreement; and

WHEREAS, the Director of Finance has reviewed the salary rates set forth below for the titles listed and certifies that they are accurate; and

WHEREAS, it is necessary to amend the Township of Bloomfield's salary ordinance to reflect the salaries contained within the Side Letter Agreement & the Collective Bargaining Agreement.

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, New

Jersey, that the Township of Bloomfield's ordinance adopting titles for employees and fixing

salary ranges is hereby amended and supplemented, so that the same shall read as follows:


SECTION 1. In all other respects all of the provisions of the aforesaid ordinance are hereby ratified and confirmed
