2017 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

**Section 1.** Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

(530) Baldwin Street, south side, starting at a point 262 feet east of the easterly curb line of East Passaic Avenue and running 20 feet east therefrom (145 Baldwin Street)

(531) Lake Street, east side, starting at a point 141 feet south of the southerly curb line of Crown Street and running 20 feet south therefrom (51 Lake Street)

(532) North 15<sup>th</sup> Street, west side, starting at a point 89 feet south of the southerly curb line of Beardsley Avenue and running 20 feet south therefrom (209 North 15<sup>th</sup> Street)

(533) North 15<sup>th</sup> Street, west side, starting at a point 93 feet north of the northerly curb line of 1<sup>st</sup> Avenue and running 20 feet north therefrom (117 North 15<sup>th</sup> Street)

**Section 2.** All ordinances inconsistent herewith are hereby repealed.

**Section 3.** This ordinance shall take effect upon final passage and publication in accordance with the law.
