2017 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

- (535) East Liberty Street, south curb, starting at a point 40 feet west of the westerly curb line of Davey Street and running 20 feet west therefrom (4 East Liberty Street)
- (536) Chester Avenue, south curb, starting at a point 159 feet west of the westerly curb line of Grove Street and running 20 feet west therefrom (116 Chester Ave)
- (537) Patton Drive, east curb, starting at a point 106 feet north of the northerly curb line of Belleville Avenue and running 20 feet north therefrom (1 Patton Drive)
- (538) Park Street, north curb, starting at a point 102 feet west of the westerly curb line of Broad Street and running 20 feet west therefrom (5 Park Street)
- (539) Broughton Avenue, east curb, starting at a point 65 feet north of the northerly curb line of Fritz Street and running 20 feet north therefrom (197 Broughton Avenue)

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.
