2017 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND CHAPTER 254, "VEHICLES AND TRAFFIC",
ARTICLE III, "Parking, Standing and Stopping", § 254-20B

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County
of Essex, State of New Jersey, that § 254-20B of the Code of the Township of Bloomfield is
hereby amended to read as follows:

It shall be unlawful for the owner or operator of a truck (including without limitation vans and pickup trucks), truck tractor, trailer, semi-trailer, commuter van, school buses including type I and Type II buses, omnibus vehicles (including taxis), motorized mobile homes (a vehicle equipped with sleeping, kitchen, or bathroom facilities), used for commercial purposes, as defined by N.J. Motor Vehicle and Traffic Regulations 39:1-1, to park such vehicles on any street in the Township of Bloomfield between the hours of 12:00 a.m. and 6:00 a.m. prevailing time. This provision shall not apply to vehicles with a gross vehicle weight rating of less than 5000 lbs., except omnibus vehicles (including taxis), which shall be prohibited regardless of weight. However, Taxis shall be allowed to park for 2 hours between the hours of 12:00 am and 6:00 am prevailing time after which they shall be prohibited from parking on any street in the Township of Bloomfield. Buses, school buses (including type I and type II buses) and omnibuses, regardless of weight, shall be allowed to park on any street in the Township of Bloomfield for no longer than 2 hours from the hours of 6:00 am to 9:00 pm. Monday through Sunday.
