2017 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

- (542) Berkeley Avenue, west curb, starting at a point 712 feet south of the southerly curb line of Franklin Street and running 20 feet north therefrom (136 Berkeley Avenue)
- (543) Vine Street, south curb, starting at a point 115 feet west of the westerly curb line of Walnut Street and running 20 feet west therefrom (10 Vine Street)
- (544) Ella Street, west curb, starting at a point 92 feet north of the northerly curb line of Cross Street and running 20 feet north therefrom (36 Ella Street)
- (545) Franklin Street, south curb, starting at a point 154 feet of the westerly curb line of Hill Street and running 20 feet west therefrom (275 Franklin Street)
- (546) Howard Street, north curb, starting at a point 427 feet of easterly curb line of Broughton Avenue and running 20 feet east therefrom (34 Howard Street)
- (547) Leslie Street, east curb, starting at a point 450 feet of the southerly curb line of Abington Avenue and running 20 feet south therefrom (140 Leslie Street)
- (548) North 15th Street, east curb, starting at a point 223 feet south of the southerly curb line of Beardsley Avenue and running 20 feet south therefrom (202 North 15th Street)
- (549) Mount Vernon Avenue, east curb, starting at a point 175 feet west of the westerly curb line of Chapel Street and running 20 feet west therefrom (34 Mount Vernon Avenue)

Section 2. All ordinances inconsistent herewith are hereby repealed.
