2017 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND CHAPTER 75, POLICE DEPARTMENT, ARTICLE I "General Provisions" IN THE CODE OF THE TOWNSHIP OF BLOOMFIELD, ESSEX, COUNTY, NEW JERSEY

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

Section 1. Chapter 75 "Police Department" Article I "General Provisions" of the Code of the Township of Bloomfield, County of Essex, State of New Jersey, is hereby amended by the addition of the following:

§ 75-5.1 Township - Controlled Side Work Fees.

A. Classification #1

Township originated based rates

For Board of Education, public entities, BCA, Township Recreation

- i. Hourly Rate Range of \$33 to \$62/per hour
- ii. No administrative fee.

B. Classification #2

Vendors requesting security for private businesses

- i. Hourly Rate of \$33 per hour, plus \$5 per hour administrative fee

C. Classification #3

Special Events (eg. Emergency security details; movies/commercial filming)

- i. Hourly Rate of \$70 per hour, plus \$5 per hour administrative fee.

D. Classification #4

Construction/Utility Company request for Traffic Control

- i. Hourly Rate of \$70 per hour, plus \$5 per hour administrative fee.

E. Classification #5

Bloomfield College security details

- i. All College events. Hourly Rate of \$50 per hour, plus \$5 per hour administrative fee.

F. Use of Township Police Vehicles

- i. Hourly Rate of \$15 per hour, per vehicle, will be added to hourly work rate.

G. Requirement of a Supervisor for an event

- i. Whenever an event or detail is utilizing 3 or more Police Officers a Supervisor will be Required and receive a rate of \$10 dollars above the Police Officer rate for the detail.

Section 2. All ordinances inconsistent herewith are hereby repealed.


Section 3. This ordinance shall take effect upon final passage and publication in accordance with the law.
