2016 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND CHAPTER 75, "POLICE DEPARTMENT", ARTICLE III "Special Law Enforcement Officers" § 75-21 "Classification; powers and duties", PARAGRAPH C IN THE CODE OF THE TOWNSHIP OF BLOOMFIELD, ESSEX, COUNTY, NEW JERSEY

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex,

State of New Jersey, as follows:

Section 1. Chapter 75 Police Department Article III "Special Law Enforcement Officers" § 75-21 "Classification; powers and duties" of the Code of the Township of Bloomfield, County of Essex, State of New Jersey, is hereby amended to add the following:


C. Auxiliary Police Force

- A. Purpose: The purpose of the Auxiliary Police Force is to assist the Township Police Department in such emergencies and other situations as the Police Director may determine.
- B. Appointments: Auxiliary police shall be appointed by the Mayor and Council, upon the recommendation of the Police Director for a one year term.
- C. Rules and Regulations: All appointed auxiliary police officers will be governed by the same Code of Conduct that has been adopted by the Township of Bloomfield.
- D. Responsibility: it shall be the responsibility of the auxiliary police to assist the Township Police Department, upon the request of the Police Director, in areas such as buildings and grounds security, enforcement of parking regulations, traffic and crowd control, document and record maintenance, and other areas of responsibility as determined by the Police Director.
- E. Training course: No person shall be appointed as an auxiliary police officer unless he/she has successfully completed a training course as approved by the Police Director.

Section 2. All ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall take effect upon final passage and publication in
