2016 ORDINANCE AMENDMENT

AN ORDINANCE TO AMEND AND SUPPLEMENT CHAPTER 387 OF THE BLOOMFIELD TOWNSHIP CODE, PROVIDING PARKING FOR PHYSICALLY LIMITED PERSONS

BE IT ORDAINED, by the Mayor and Council of the Township of Bloomfield, County of Essex, State of New Jersey, as follows:

**Section 1.** Chapter 387, entitled: "PARKING FOR HANDICAPPED", Section 387-4A "Enumeration of restricted parking areas", of the Code of the Township of Bloomfield is hereby amended by the addition of the following:

- (483) Jerome Place, south side, starting at a point 397 feet from the westerly curb line of Berkeley Avenue and running 20 feet west therefrom (156 Jerome Place)
- (484) Morton Street, east side, start at a point 62 feet from the southerly curb line of Belleville Avenue and running 20 feet south therefrom ( 38 Belleville Ave.)
- (485) Lexington Avenue, east side, starting at a point 201 feet from the westerly curb line of Fontaine Street and running 20 feet west therefrom (121 Lexington Avenue)
- (486) Baldwin Street, south side, starting at a point 224 feet from the easterly curb line of East Passaic Avenue and running 18 feet east therefrom (139 Baldwin Street)
- (487) Baldwin Street, south side, starting at a point 311 feet from the westerly curb line of North Spring Street and running 20 feet west therefrom (150 Baldwin Street)
- (488) Baldwin Street, south side, starting at a point 253 feet from the easterly curb line of North Spring Street and running 20 feet west therefrom (152 Baldwin Street)

**Section 2.** All ordinances inconsistent herewith are hereby repealed.

**Section 3.** This ordinance shall take effect upon final passage and publication in accordance with the law.
